

**CALHOUN COUNTY FAIR

“EXHIBITORS CONTRACT”
(Inside and outside of K-Mar Building)**

September 9, 10, 11, & 12, 2021

This contract represents an agreement between

and the Calhoun County Fair Association

The space is located in and outside the K-Mar Building and consists of nine (9) feet frontage and approximately ten (10) feet in depth. The building is locked when not in use. The fee for this space is \$75.00 per single space payable IN ADVANCE. It is payable with cash, check or money order. The contract must be returned to the Exhibit Chairman no later than August 31 to assure that space is available. Spaces will be assigned on a first come, first serve basis. One exhibitor's pass is included in the fee.

The Board agrees to furnish one, 110V outlet per space to be used for exhibit only. The exhibitors are absolutely prohibited from using the electrical facilities for personal use, such as camper hookups, etc.

The Board further agrees to furnish a night watchman on the grounds, but will not be liable for loss of or damage to any property brought to, or caused to be brought to the fairgrounds by the exhibitors, nor for personal injury to exhibitor, employee of exhibitor, or persons visiting the area purchased by exhibitors. It is specifically agreed that no beverages with alcoholic content will be brought to or consumed on the grounds.

“The sale of throwing stars, knives, any projectile, shooting guns, smoking paraphernalia, silly string, snap-n- pops, colored hair spray, fart bombs or anything resembling such is strictly forbidden.”

The Exhibit Chairman reserves the right to assign space to each exhibitor in the best interests of a successful and well rounded show. It is further agreed that no refunds will be made by the Board. It is agreed that this contract is binding on successors and assigns of parties here to and cannot be altered except by written agreement between the Exhibit Chairman and the exhibitor.

Violation of any of the terms and conditions of this agreement by the exhibitor, whether before or during the show, shall on written notice from the Board result in forfeiture of the purchases space of said exhibitor and all moneys paid by the exhibitor shall be retained by the Board as liquidated damages.
